- No outside medications will be accepted into the Jail.

MONEY FOR INMATE ACCOUNT –

- Will be accepted Sun during visitation & Mon-Fri 8-5pm
- Inmates will have a store on Wednesday & Sunday Evenings.
- Only Money orders may be mailed in (personal checks will NOT be accepted)

TELEPHONE CALLS

- Collect Calls are managed by Telmate (866-348-6231)
- Inmates have access to the telephone for collect calls, unless a disciplinary action has removed this privilege, until 10:00 pm each night.
- Sheriff Department Employees are <u>not allowed</u> to give messages to inmates.

VISITATION

Sunday 2:30 - 3:30 pm

Trustee Visitation 12:00 – 1:30 pm

Rules For Visitation: (If male's visitation is cut short, female's visitation will be terminated as well (& vice-versa)

1 visitor per inmate – (males allowed 2 if weather conditions allow outdoor visitation – if held inside limited to 30 min per side). If a family member has two sons here, he/she may visit both.

If a visitor is a former inmate, he/she must have been bonded for at least 30 days.

Visitors must wear appropriate clothing – no sleeveless shirts, pants must come below knee, mid-drift must be covered.

One Visitor – One Inmate. If you sign in to see an inmate and that visit ends – you can't visit a different person.

If you sign in to see a male, you cannot see a female inmate when that visit

ends. Visitor must keep hands to self at all times, no hugging or touching inmates. Visitors can not cross or touch barrier (ropes or police tape).

Items will not be passed to/from inmates.

Appropriate language and volume must be respected – no cursing or yelling – such events will get visitor ejected & banned.

No cell phones, handbags, tobacco or weapons of any kind (including pocket knives)

No packages during visitation, visitors must wait until after visitation to receive property.

All visitors are subject to being searched

All visitors are subject to NCIC check
